# Verve, a Credit Union 82<sup>nd</sup> ANNUAL MEETING March 18, 2019

### I. CALL TO ORDER

Board Chair, Victoria Beltran, called the 82<sup>nd</sup> Annual Meeting of Verve, a Credit Union to order at 5:34 p.m. on Monday, March 18, 2019 at the Verve Universal Street branch. Video of the Annual Meeting was also live broadcast to the Main Street, La Crosse branch.

# II. DETERMINATION OF QUORUM

Chair Beltran stated that according to the Verve, a Credit Union By-laws, 25 members constituted a quorum. There were 118 members present; therefore, a quorum was established.

He noted that the Enterprise Risk Management (ERM) Committee regularly reviews internal audits done at the Credit Union and that those audits show operations, records and finance are in good order. He reviewed the Credit Union's financials, also highlighted on the 2018 Annual Report, which indicated excellent growth over the past year and a very positive outlook for the year ahead.

# B. <u>Nominating Committee's Report, Brian Borchardt</u>

Brian Borchardt, Chair of the 2018 Nominating Committee, announced that there were four Board members up for re-election and that no outside requests received for the open positions. Borchardt also noted that the Board had voted to reduce the number of directors that serve on the Board to 7 and will determine if additional directors shall be appointed at a future time.

Borchardt declared Kevin Bornemann, Bill Colclough and Garth Wicinsky each reelected for an additional three-year term, and Victoria Beltran re-elected for a one-year term. Borchardt congratulated the re-elected Board members and encouraged all members to apply for Board positions as they become available.
