CONTEST RULES

DATES OF “SINFONIA FUNDRAISER VIDEO” CONTEST: The Contest begins on March 27, 2023 and ends on April 14, 2023 (“Contest Period”).

ELIGIBILITY: This Sinfonia Fundraiser Video Contest (the “Contest”) is only open to those who are Sinfoniacs actively fundraising in the 2023 Sinfonia fundraiser, will be playing an instrument in the final concert, are eighteen (18) years of age or older and reside in the United States (the “Entrant”). The Contest is subject to all federal, state, and local laws and regulations. This Contest is void outside of Wisconsin. By entering this Contest, Entrants indicate their full and unconditional agreement to, and acceptance of, these Official Rules and the decisions of Verve, a Credit Union (the Sponsor”).)

HOW TO PARTICIPATE: Entrants can enter the contest by uploading a two minute or less video (the “Video Submission”) of themselves showing energy, enthusiasm...or should we say Verve, with their instrument to <https://www.verveacu.com/sinfonia/> during the Contest Period. **There is a limit of one (1) Video Submission per Entrant during the Contest Period.**

This Contest is in no way sponsored, endorsed or administered by, or associated with Facebook. You understand that you are supplying your information to the Sponsor and not to Facebook.

SUBMISSION RESTRICTIONS: Qualifying Video Submissions must be no longer than two minutes in length.

Video Submissions not meeting the requirements as set forth in these Official Rules or that contain prohibited, inappropriate, or irrelevant content, as determined by Sponsor in its sole discretion, will not be eligible and will be disqualified. The Released Parties (defined in the “NO LIABILITY” section below) are not responsible for any Video Submission that is lost, late, misdirected or undeliverable, whether due to system errors, omissions, interruptions, deletions, defects, delays in operation or transmissions or any other reason, theft or destruction or failures, faulty transmissions or other telecommunication malfunctions, Video Submissions not received resulting from any hardware or software failures of any kind, lost or unavailable network

connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, technical malfunctions, or otherwise.

By participating, Entrant agrees that their Video Submission may be shared on social media sites or other websites by the Sponsor.
